#### **ORDER**

As per G.O(P)No.515/85/Fin. dated 16.09.1985 (Third Pay Revision Order), the benefit of Ratio Promotion scheme (1:1:3) had been introduced to the category of Trade Instructor in this department. The cadre strength of Trade Instructors in different grades fixed as on 6.8.2021 vide proceedings read as 2 <sup>nd</sup> Paper is as follows:

Trade Instructors (Senior Grade) = 210

Trade Instructors (Grade-I) = 210

Trade Instructors (Grade-II) = 629

Total strength = 1049 (as on 6.8.2021).

On the basis of this, ratio promotion was sanctioned to Trade Instructors against the vacancies that arose upto 6.8.2021 as per the proceedings read as 2<sup>nd</sup> above. Now, having arisen some vacancies (after 6.8.2021) consequent on promotion of some incumbents in the Senior Grade and I <sup>st</sup> Grade, the following senior most Trade Instructors (Grade-I) are temporarily promoted as Trade Instructors (Senior Grade) on Rs.41300-87000 and the senior most Trade Instructors (Grade-II) as Trade Instructors (Grade-I) on Rs. 39300-83000 under Rule 28 (a) of the General Rules in the K.S & S.S Rules 1958.
